



Non renewal of the certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by the local self Government/Revenue department. All Officers of and above the rank of Station Officers of the fire and Rescue Services Department will have the right to inspect the building on any day/time to ensure that the installed systems are in good working condition.

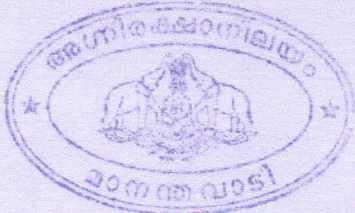


